I, Pooja Sawarkar, proprietor of M/s. Pooja Sawarkar & Associates, Company Secretaries in Practice (Membership no. The Company has engaged the services of National Securities Depository Limited (NSDL) for remote e-voting.

The Management of the Company is responsible to ensure the compliance with the requirements of the Act and the Rules including MCA Circulars and Listing Regulations relating to remote e-voting for the resolution contained in the Postal Ballot Notice dated 14<sup>th</sup> August, 2025. Our responsibility as a Scrutinizer is to ensure that the remote e-voting is carried out in a fair and transparent manner and to make a scrutinizer's report on the votes cast "IN FAVOUR" or "AGAINST" on the resolution contained in the Postal Ballot Notice dated 14<sup>th</sup> August, 2025 based on the reports generated from the e-voting system provided by NSDL.

Members holding shares as on Friday, 8th August, 2025, "cut-off date", were entitled to vote on the resolution stated in the Notice.

The remote e-voting period was open from Friday, 15th August, 2025 at 9.00 a.m. (IST) and was closed on Saturday, 13th September, 2025at 5.00 p.m. (IST). After closure of the voting period on Saturday, 13th September, 2025 5.00 p.m., the NSDL portal was blocked for voting.

The votes cast by remote e-voting were authorised on Saturday, 13th September, 2025 and the e-voting results / list of members who have voted for and / or against were downloaded from the e-voting website of NSDL.
