Textual Information(2)	Due to SEBI prohibitions from dealing in shares in the company by and freeze of demat accounts of all the Promoters and Promoter Group of the company by BSE Limited, complete dematerialisation of their shares could not be effected.
Textual Information(3)	SEBI vide its Order dated 30.09.2019 granted the Company relaxation from compliance of Minimum Public Shareholding for the purpose of voluntary delisting. However, the delisting process was unsuccessful . The company has again received SEBI's consent vide letterdated 03.12.2024 for voluntary delisting of the share s of the company, however, the voluntary delisting could not be processed and completed during the period specified by SEBI.
